RELEASE OF ALL CLAIMS AND WAIVER OF LIABILITY

WARNING: By signing this release, you give up the right to sue. PLEASE READ CAREFULLY

The undersigned wishes to take part in an expedition with Edward Bekker Ski & Alpinisme (hereinafter referred to as EB).

The undersigned is aware that, as an adventure traveller, he or she will, in addition to the usual dangers inherent in skiing or mountaineering tours, be exposed to certain additional dangers and risks specific to travel in remote areas as Alaska, Canada, South America, Himalayas and in remote areas in any other part of the world.

The undersigned acknowledges that the enjoyment and excitement of adventure travel to such regions is derived in part from participation in activities in an extreme environment far from the facilities of modern civilization and that the inherent risks of travel in this environment contribute to such enjoyment and excitement.

As a condition of and in consideration for EB permitting the undersigned to participate in the Expedition, the undersigned agrees as follows:

1. To assume all of the risks inherent in adventure travel that may result both from participation in the Expedition itself and in transportation to or from the Expedition route, including without limitation the risk of personal injury, death, loss or damage to person or property and any loss, costs or expenses resulting therefrom;
2. To waive any and all claims the undersigned may now and in the future have against, and release from all liability and not to sue EB or any of its guides, agents, representatives, contractors, or suppliers (or collectively "its staff") for any personal injury, death, property damage or any other loss, damage, costs or expenses sustained by the undersigned arising from any cause whatsoever, including without limitation, the negligence of EB or any of its staff;
3. That the undersigned is medically, physically and in all other respects, fit and fully able to participate in adventure travel and that the undersigned has no special medical requirements or conditions.
4. That the undersigned is responsible for his or her own medical and life insurance coverage.
5. That the undersigned enters into this Agreement and has elected to participate in the Expedition of his or her own free will.

The undersigned acknowledges and confirms that he or she is of the full age of 19 years and having read and understood this Agreement in its entirety, agrees to be bound by all of the terms hereof and further confirms that this Agreement will be binding on his or her heirs, next of kin, executors, administrators and successors.
